One America News has extensively covered the dangers of the experimental chemical injections the government is calling the Covid vaccine. In fact, when the holy alliance story hit the stands, **there was virtually no arena of federal legislative activity, according to The 1992 World Almanac of US Politics, that was not directly controlled by a Roman Catholic senator or representative.** The committees and subcommittees of the United States Senate and House of Representatives governing commerce, communications and telecommunications, energy, medicine, health, education and welfare, human services, consumer protection, finance and financial institutions, transportation, labor and unemployment, hazardous materials, taxation, bank regulation, currency and monetary policy, oversight of the Federal Reserve System, commodity prices, rents services, small business administration, urban affairs, European affairs, Near Eastern & South Asian affairs, terrorism/narcotics/ international communications, international economic/trade/ oceans/environmental policy, insurance, housing, community development, federal loan guarantees, economic stabilization measures (including wage and price controls), gold and precious metals transactions, agriculture, animal and forestry industries, rural issues, nutrition, price supports, Food for Peace, agricultural exports, soil conservation, irrigation, stream channelization, flood- control, minority enterprise, environment and pollution, appropriations, defense, foreign operations, vaccines, drug labeling and packaging, drug and alcohol abuse, inspection and certification of fish and processed food, use of vitamins and saccharin, national health insurance proposals, human services, legal services, family relations, the arts and humanities, the handicapped, and aging – in other words, virtually every aspect of secular life in America – came under the chairmanship of one of these Roman Catholic laypersons:

Vatican Council II's Constitution on the Church (1964) instructs politicians to use their secular offices to advance the cause of Roman Catholicism. Catholic laypersons, "whoever they are, are called upon to expend all their energy for the growth of the Church and its continuous sanctification," and "to make the Church present and operative in those places and circumstances where only through them can it become the salt of the earth" (IV, 33). Vatican II further instructs all Catholics "by their competence in secular disciplines and by their activity [to] vigorously contribute their effort so that ... the goods of this world may be more equitably distributed among all men, and may in their own way be conducive to universal progress in human and Christian freedom ... and [to] remedy the customs and conditions of the world, if they are an inducement to sin, so that they all may be conformed to the norms of justice and may favor the practice of virtue rather than hinder it." (IV, 36).

Vatican II affirms Catholic doctrine dating back to 1302, when Pope Boniface VIII asserted that *"it is absolutely necessary for the salvation of every human creature to be subject to the Roman Pontiff."* This was **the inspiration for the papacy to create the United States of America that materialized in 1776**, by a process just as secret as the Reagan-Vatican production of Eastern Europe in 1989. What? American government Roman Catholic from the *beginning*?

Consider: the land known today as the District of Columbia bore the name "Rome" in 1663 property records; and the branch of the Potomac River that bordered "Rome" on the south was called "Tiber." This information was reported in the 1902 edition of the Catholic Encyclopedia's article on Daniel Carroll. The article, specifically declaring itself "of interest to Catholics" in the 1902 edition, was deleted from the New Catholic Encyclopedia (1967). Other facts were reported in 1902 and deleted from 1967. For example, when Congress met in Washington for the first time, in November, 1800, "the only two really comfortable and imposing houses within the bounds of the city" belonged to Roman Catholics. One was Washington's first mayor, Robert Brent. The other was Brent's brother-in-law, Notley Young, a Jesuit priest.

Daniel Carroll was a Roman Catholic congressman from Maryland who signed two

of America's fundamental documents, the Articles of Confederation and the United States Constitution. Carroll was a direct descendant of the Calverts, a Catholic family to whom King Charles I of England had granted Maryland as a feudal barony. Carroll had received his education at St. Omer's Jesuit College in Flanders, where young English-speaking Catholics were trained in a variety of guerrilla techniques for advancing the cause of Roman Catholicism among hostile Protestants.

In 1790, President George Washington, a Protestant, appointed Congressman Carroll to head a commission of three men to select land for the "federal city" called for in the Constitution. Of all places, the commission chose "Rome," which at the time consisted of four farms, one of which belonged to... Daniel Carroll. It was upon Carroll's farm that the new government chose to erect its most important building, the Capitol.

THE American Capitol abounds with clues of its Roman origins. "Freedom," the Roman goddess whose statue crowns the dome, was created in Rome at the studio of American sculptor Thomas Crawford. We find a whole pantheon of Roman deities in the great fresco covering the dome's interior rotunda: Persephone, Ceres, Freedom, Vulcan, Mercury, even a deified George Washington. These figures were **the creation of Vatican artist Constantino Brumidi.**





The fact that the national Statehouse evolved as a “capitol” bespeaks Roman influence. **No building can rightly be called a capitol unless it’s a temple of Jupiter**, the great father-god of Rome who ruled heaven with his

thunderbolts and nourished the earth with his fertilizing rains. If it was a capitolium, it belonged to Jupiter and his priests.

Jupiter's mascot was the eagle, which the founding fathers made their mascot as well. A Roman eagle tops the governing idol of the House of Representatives, a forty-six-inch sterling silver and-ebony wand called a "mace." The mace is "the symbol of authority in the House." When the Sergeant-at-arms displays it before an unruly member of Congress, the mace restores order. Its position at the rostrum tells whether the House is in "committee" or in "session."

America's national motto "Annuit Coeptis" came from a prayer to Jupiter. It appears in Book IX of Virgil's epic propaganda, the Aeneid, a poem commissioned just before the birth of Christ by Caius Maecenas, the multi-billionaire power behind Augustus Caesar. The poem's objective was to fashion Rome into an imperial monarchy for which its citizens would gladly sacrifice their lives.

Fascism may be an ugly word to many, but its stately emblem is apparently offensive to no one. The emblem of fascism, a pair of them, commands the wall above and behind the speaker's rostrum in the Chamber of the House of Representatives. They're called fasces, and I can think of no reason for them to be there other than to declare the fascistic nature of American republican democracy.



A fasces is a Roman device. Actually, it originated with the ancient Etruscans, from whom the earliest Romans derived their religious jurisprudence nearly three thousand years ago. It's an axe-head whose handle is a bundle of rods tightly strapped together by a red sinew. It symbolizes the ordering of priestly functions into a single infallible sovereign, an autocrat who could require life and limb of his subjects. If the fasces is entwined with laurel, like the pair on the House wall, it signifies Caesarean military power. The Romans called this infallible sovereign Pontifex Maximus, "Supreme Bridgebuilder." No Roman was called Pontifex Maximus until the title was given to Julius Caesar in 48 BC. Today's Pontifex Maximus is Pope John Paul II.

As we shall discover in a forthcoming chapter, John Paul does not hold that title alone. He shares it with a mysterious partner, a military man, a man holding an office that has been known for more than four centuries as "Papa Nero," the Black Pope. I shall present evidence that the House fasces represent the [Black Pope](#), who indeed rules the world.

# What Makes A Nation Great? An American Independence Day Message

## **What Makes A Nation Great?**

On this date (July 4) in 1776, the 13 colonies declared their independence from England. It would not be until 1783 before they actually gained their freedom at the signing of the Treaty of Paris. The document upon which all our laws are based is the Constitution which was signed in 1787. The Founding Fathers wrote the Constitution whose very foundation was established upon what was then known as "Natural Law." One of the most referenced sources cited by the Founding Fathers during the writing and discussion of the Constitution was from Blackstone's Commentaries of English Law. Blackstone maintained that Natural Law was given to mankind by God. These God-given principles were to aid man in their governance. Thus, our Constitution reflects those very statutes which were ordained by God. The apostle Paul alluded to these principles that govern in the hearts of mankind with these words as found in Romans 1:19, 20 and 2:14, 15.

"Because that which may be known of God is manifest in them; for God hath shewed it unto them. For the invisible things of him from the creation of the world are clearly seen, being understood by the things that are made, even his eternal power and Godhead; so that they are without excuse."

"For when the Gentiles, which have not the law, do by nature the things contained in the law, these, having not the law, are a law unto themselves.

Which shew the work of the law written in their hearts, their conscience also bearing witness, and their thoughts the mean while accusing or else excusing one another."

A person who greatly influenced and inspired the Founding Fathers was John Locke who wrote about that "Natural Law" that formed the very foundation of our nation. Listen to his words: "The State of Nature has a Law of Nature to govern it which obliges everyone...that being all equal and independent no one ought to harm another in his Life, Health, Liberty, or Possessions." Notice the obvious similarity of wording as that also found in the Declaration of Independence. One historian made the comment that it was the Declaration of Independence which should actually be considered America's foundation and the Constitution was the house upon which it was built. Anna Beth Rankin wrote that, "The Constitution is the Supreme Law of the United States; however it has its philosophical roots in the Declaration of Independence." To this agrees the statement made by Abraham Lincoln, "the Declaration of Independence was an 'apple of gold' whereas the Constitution was the 'picture of silver' framed around it." The point being stressed here is that the Natural Law, as expressed in the Declaration, was laws and rights given by God, whereas the Constitution was made of laws created by man.

The Framers and early Supreme Court Justices relied heavily on the concepts as found in the Natural Law. Through the years, the Courts have strayed further and further from these original principles of law and justice. In fact, Supreme Court Justice Clarence Thomas was once castigated by a Harvard Law professor for adhering to these principles of Natural Law. It has been the trend for several decades now to treat the Constitution as a "living document." As a result, it has been relegated to an obsolete and discarded document in favor of a more fluid social construct which is entirely relative to the whims of a changing society.

In fact, former President Barack Obama made this shocking statement: "We are no longer just a Christian nation." In his speech, President Obama alluded to the fact that we might have once been a Christian nation, but no longer. What he said is entirely correct. But our magnificent nation was indeed founded upon Christian principles. Two professors, Donald S. Lutz and Charles S. Hyneman made an exhaustive study of our Founders' most read books, newspaper articles, and monographs with explicit political content. They limited their study to the period from 1760 to 1805. They concluded that the most often cited source was the Bible. This should come as no surprise especially as one reflects upon the words of Benjamin Franklin at the Constitutional Convention. Listen to the wisdom coming from this 81 year-old statesman.

"I have lived, Sir, a long time; and the longer I live, the more convincing proofs I see of this truth, that God governs in the affairs of men. And if a sparrow cannot fall to the ground without his notice, is it probable that an empire can rise without his aid? We have been assured, Sir, in the sacred writings that 'except the Lord build the house, they labor in vain that build it.' I firmly believe this; and I also believe that, without his concurring aid, we shall succeed in this political building no better than the builders of Babel... I therefore beg leave to move that, henceforth, prayers imploring the assistance of heaven and its blessings on our deliberations be held in

this assembly every morning before we proceed to business, and that one or more of the clergy of this city be requested to officiate in that service."

Just a few years later, our nation's second President, John Adams, echoed these sentiments when he said, "Our Constitution was made only for a moral and religious people. It is wholly inadequate to the government of any other." It is understandable for those who do not like the "strict constructionist" interpretation of the Constitution when one reflects upon our present societal morality. In this sense, the Constitution is becoming more and more foreign to the thought processes of a liberal and progressive culture.

There was a time in Israel's history when they were regarded as a great nation, although small in territory and in population. What made them great? To find this answer, we need to go back to their very founding. Listen to the words of Moses as he instructs the children of Israel before they entered the land of Canaan:

"Behold, I have taught you statutes and judgments, even as the LORD my God commanded me... Keep therefore and do them; for this is your wisdom and your understanding in the sight of the nations, which shall hear all these statutes, and say, Surely this great nation is a wise and understanding people." (Deut. 4:5, 6)

Just as the nation of Israel began as a great nation because they were founded upon Godly principles and laws, so too was the United States great because they founded our Constitution upon these same fundamental truths. Alexis de Tocqueville has been quoted as saying that, "America is great because America is good. When America ceases to be good, she will cease to be great." Although this quote has never been verified, its words bear much truth and are truly sublime.

"Blessed is the nation whose God is the LORD."

For almost 200 years, it was an accepted premise that our nation was founded upon Christian principles. In fact, John Adams, the second President of the United States, made this declaration:

*"Our Constitution was made only for a moral and religious people. It is wholly inadequate to the government of any other."*

Although many people believe, unwittingly, that the Constitution contains the phrase "separation of Church and State" or "wall of separation", these phrases are to be found nowhere within the Constitution or the Bill of Rights. We find their origin, however, in a letter written by Thomas Jefferson to the Danbury Baptist Association in 1802. In this letter, Jefferson uses the phrase, "a wall of separation between Church and State." Contrary to the popular opinion of today, Jefferson's use of the phrase meant that the Church should be protected from the State or government, and not, that the State must be protected from the Church. It was President Thomas Jefferson, in 1803, that recommended Congress appropriate funds "for civilizing the Indians and promoting Christianity." Actually, he signed

appropriation bills to Christianize the Indians three different times during his presidency.

For over 100 years, the Bible was used as a textbook in our public schools. Sadly, though, this tradition of a Christian America was dealt a serious blow by the Supreme Court in several consecutive rulings beginning in 1962 and culminating in June, 1963. It was through these rulings that both prayer and Bible reading were removed from the public school system. This Supreme Court decided its decision with a 8 to 1 ruling. The majority, in writing its opinion, stated that their ruling was one of "wholesome neutrality". They further stated that their decision would in no way be deemed as a victory for "secularism". We know now that it did have this "unintended consequence".

As a result of these rulings, our nation began to lose its vision and sight. We no longer can distinguish between good and evil. Just a few years after this Supreme Court ruling, Joseph Fletcher in 1966 wrote a book titled Situation Ethics . In the book, Fletcher argues that there are no moral absolutes, everything is relative. Infidelity, stealing, lying and a myriad of other moral turpitudes might be acceptable depending on the situation. In the Old Testament, during the period of the judges, the Bible records that "every man did that which was right in his own eyes."

Since our nation's founding, the Bible has been used as the rule of law and has acted as the guide for our country's morality. Obviously, our moral conscience as a nation has deteriorated and crumbled. We have forsaken the only moral compass that has ever been given to mankind.

Is there any hope left for America, for the Church? The answer is yes. With regard to the Church, we must individually and corporately confess that we have sinned and failed in our duty and responsibility to God. We must again turn to the Bible and let God's Word lead us and guide us in all aspects of our life. After we have done this, we can then stand on the promise of God as quoted in 2 Chron.7:14.

practicing **Catholic**.



## [The 45 Goals of Communism](#)



I just saw a 2010 documentary film entitled, "*Agenda: Grinding America Down*" about the leftist socialist takeover of America. It talks about a book written in 1958 by a former FBI Agent, Cleon Skousen, called "*The Naked Communist*". On Jan. 10, 1963, Congressman Albert S. Herlong Jr. of Florida read this list of 45 Communist goals into the Congressional Record. How many of these 45 goals do you think have been implemented? You can write your answer in the comments section below.

Some of the goals are dated due to the collapse of the Soviet Union and the unification of East and West Germany, but from my observation, the goals have been fulfilled or close to fulfillment by the liberal leftist socialists –

most of the current American Democratic party members. I enhanced in **bold font** the ones I especially find disturbing.

1. U.S. should accept coexistence as the only alternative to atomic war.
2. U.S. should be willing to capitulate in preference to engaging in atomic war. [Note: These encapsulate the Kennan Doctrine, which advocated for the "containment" of communism. Establishment figures supporting the amoral containment policy at least implicitly worked with the communists in scaring the wits out of the American people concerning atomic war. President Ronald Reagan undid the doctrine when he took an aggressive stand against the Evil Empire by backing freedom fighters from around the world that were struggling against the left-wing communist jackboot. As a result, the Soviet Union and its satellites imploded, a considerable and unexpected setback to the international communist edifice.]
3. Develop the illusion that total disarmament by the U.S. would be a demonstration of "moral strength." [Note: The nuclear freeze advocates supported a freeze on American nuclear development only. Rarely were Soviet nukes or those of other nations mentioned in their self-righteous tirades. The same advocates now call for reducing American military might, claiming that there is something immoral about America preserving its military pre-eminence in the world.]
4. Permit free trade between all nations regardless of Communist affiliation and regardless of whether or not items could be used for war. [Note: Today, there are calls to end the embargo on the slave island of Cuba, there were complaints about the embargo against Iraq, and the U.S., not Saddam Hussein, was blamed for the suffering of the Iraqi people. Would they have advocated for free trade with Hitler and his National Socialist regime?]
5. Extend long-term loans to Russia and Soviet satellites.
6. Provide American aid to all nations regardless of Communist domination. [Note: Such aid and trade over decades contributed greatly to the left-wing communist liquidation of over 100 million people worldwide, according to the well-documented "Black Book of Communism." This aid and trade marks a shameful chapter in American history. Without the aid and trade, the left-wing international communist behemoth would have imploded on its own rot a lot sooner and umpteen millions would have been saved from poverty, misery, starvation and death.]
7. Grant recognition of Red China and admission of Red China to the U.N. [Note: Not only did President Nixon fulfill this goal but he also betrayed America's allies in Nicaragua, El Salvador, Iran, Afghanistan, Angola and elsewhere.]
8. Set up East and West Germany as separate states in spite of Khrushchev's promise in 1955 to settle the Germany question by free elections under supervision of the U.N.
9. Prolong the conferences to ban atomic tests because the U.S. has agreed to

suspend tests as long as negotiations are in progress.

10. Allow all Soviet satellites individual representation in the U.N.

11. **Promote the U.N. as the only hope for mankind.** If its charter is rewritten, demand that it be set up as a one-world government with its own independent armed forces. [Note: There are still American intellectuals, and elected members of Congress, who dream of an eventual one world government and who view the U.N., founded by communists such as Alger Hiss, the first secretary-general, as the instrument to bring this about. World government was also the dream of Adolf Hitler and J.V. Stalin. World government was the dream of Osama bin Laden and the 9/11 hijackers.]

12. Resist any attempt to outlaw the Communist Party. [Note: While the idea of banning any political party runs contrary to notions of American freedom and liberty, notions that are the exact opposite of those held by the left-wing communists themselves, nevertheless these goals sought to undermine the constitutional obligation of Congress to investigate subversion. The weakening of our government's ability to conduct such investigations led to the attack of 9/11.]

13. Do away with loyalty oaths. [Note: It is entirely proper and appropriate for our government to expect employees, paid by the American taxpayer, to take an oath of loyalty.]

14. Continue giving Russia access to the U.S. Patent Office.

15. **Capture one or both of the political parties in the U.S.** [Note: In his book, "Reagan's War," Peter Schweizer demonstrates the astonishing degree to which communists and communist sympathizers have penetrated the Democratic Party. In his book, Schweizer writes about the presidential election of 1979.]

16. **Use technical decisions of the courts to weaken basic American institutions, by claiming their activities violate civil rights.** [Note: This strategy goes back to the founding of the American Civil Liberties Union by Fabian Socialists Roger Baldwin and John Dewey and Communists William Z. Foster and Elizabeth Gurley Flynn among others.]

17. **Get control of the schools.** Use them as transmission belts for Socialism and current Communist propaganda. Soften the curriculum. Get control of teachers associations. Put the party line in textbooks.

18. **Gain control of all student newspapers.**

19. Use student riots to foment public protests against programs or organizations that are under Communist attack. [Note: The success of these goals, from a communist perspective, is obvious. Is there any doubt this is so?]

20. **Infiltrate the press.** Get control of book review assignments, editorial writing, policy-making positions.

21. **Gain control of key positions in radio, TV & motion pictures.**
22. Continue discrediting American culture by degrading all form of artistic expression. An American Communist cell was told to "eliminate all good sculpture from parks and buildings," substituting shapeless, awkward and meaningless forms.
23. **Control art critics and directors of art museums.** "Our plan is to promote ugliness, repulsive, meaningless art."
24. **Eliminate all laws governing obscenity by calling them "censorship" and a violation of free speech and free press.**
25. **Break down cultural standards of morality by promoting pornography and obscenity in books, magazines, motion pictures, radio and TV.** [Note: This is the Gramscian agenda of the "long march through the institutions" spelled out explicitly: gradual takeover of the "means of communication" and then using those vehicles to debauch the culture and weaken the will of the individual to resist.]
26. **Present homosexuality, degeneracy and promiscuity as "normal, natural and healthy."** [Note: Today those few who still have the courage to advocate public morality are denounced and viciously attacked. Most Americans are entirely unwitting regarding the motives behind this agenda.]
27. **Infiltrate the churches** and replace revealed religion with "social" religion. **Discredit the Bible** and emphasize the need for intellectual maturity, which does not need a "religious crutch." [Note: This has been largely accomplished through the communist infiltration of the National Council of Churches, Conservative and Reform Judaism, and the Catholic seminaries.]
28. **Eliminate prayer or any phase of religious expression in the schools** on the grounds that it violates the principle of "separation of church and state"
29. **Discredit the American Constitution** by calling it inadequate, old fashioned, out of step with modern needs, a hindrance to cooperation between nations on a worldwide basis.
30. **Discredit the American founding fathers.** Present them as selfish aristocrats who had no concern for the "common man."

**Stew Peters:** So we're now up to our fourth COVID shot here in the United States. And Anthony Fauci is talking about possibly doing another round of lockdowns too. Hell, I mean, that might happen because half of this country are sheep, and will fall for anything, it seems.

Well, Dr. David Martin recently warned that the ultimate long-term purpose of all of this will be exposing humanity to constant forcible gene editing, via mRNA vaccines and who knows what else. Dr. Martin will be joining me I'm very excited because he also will be speaking at the April let's go Brandon rally, but he joins us now. And I'm excited about that, as well. Thank you for coming. So that's what this is replacing God's likeness, essentially, as we worship the mRNA masters.

**Dr. David Martin:** You know, it's fascinating. And just the last couple of weeks, I have gone on record for quite some time now, Stew, saying that this entire exercise was about transcribing a computer-synthesized model into the human genome. And in the last month, we've seen mainstream science come back with a giant revelation that it turns out that this shot persists in the human body for an indeterminate period of time. The most recent data shows that at least surviving up to eight weeks in the lymph system, where it continually produces the spike protein. We see evidence coming from municipal waste systems that allegedly even though we're all allegedly getting better, and the pandemic is starting to normalize, apparently spike protein is showing up in our waste streams at alarmingly high rates. Stew, the reason is because as I've said all along, when you inject the body with instructions to make a chimeric model of a synthetic spike protein, where you have never done testing on that gene therapy, it turns out that you don't know what you might be manufacturing, and how long each individual who gets the injection might be manufacturing these pathogens. And not surprisingly, we were told about this years before this injection started. This is a pandemic of the bio weaponization of the human organism. This is not public health. And Anthony Fauci is the architect of this genocide.

**Stew Peters:** You have read so many different quotes and given so many examples using the criminals' own words as they have forecasted exactly what was coming and this dates all the way back. I mean, everybody I talked to that has relevant resources can trace this first, it was back to 2015. Then it was 2005. And now even before that, is it possible,...

**Dr. David Martin:** Yeah, all the way to 1990.

**Stew Peters:** 1990? I mean, now. Is this, is it possible? Why? What are some other reasons that this could be showing up in our water?

**Dr. David Martin:** Well, listen, the reason is really simple. We are now obsessing about the fact that every way to Sunday, what is being done is the human organism is now being modified, and it is being modified to perpetually produce a toxic protein known and scheduled to harm humanity. And when I say known and scheduled to harm humanity, why don't we go ahead and make sure I clarify the reference because apparently, people don't understand what it is. Under 7 CFR Part 331, under 9 CFR Part 121, and on 42 CFR Part 73, we have what's called the Federal Select Agent Toxin List. Stew, **this is not my list. This is not Dave's allegation. This is the Code of Federal Regulations where we put very specific toxins on a schedule and say these things are known to harm humans.** They are known to be damaging, and they are subject to the biological and chemical weapons treaties and laws that we have enforced here in the United States. And why don't we read it directly from the schedule because why would I need to make up for the criminals' acts are even more egregious? Any SARS CoV or SARS CoV2 chimeric virus resulting from any deliberate manipulation of SARS CoV2 to incorporate nucleic acids coding for SARS CoV virulence factors. Stew, they actually say that doing the thing they're doing is illegal.

**Stew Peters:** Hold on, read that again.

**Dr. David Martin:** Right. Sars CoV and SARS CoV2 chimeric viruses resulting from any deliberate manipulation of SARS CoV2 to incorporate nucleic acids coding for SARS CoV2 virulence factors. That's actually in three sections of the Code of Federal Regulations subject to the biologic and toxin agent program, defined under 18 US Code section 178, as a biological agent subjected to 18 US Code section 175 prohibition of biological weapons. Literally, the statute says what they're doing is a felony punishable by 99 years in prison, and up to \$100 million per count.

**Stew Peters:** If you didn't think that that was going to happen. And if you didn't think that justice was going to prevail, and if you didn't think that we were going to win, then you wouldn't be fighting as hard as you are, you're fighting because there really was a purpose and you see a way to win, we're going to win, aren't we?

**Dr. David Martin:** That's exactly right. And, and so it's important when, when, when, still, you know, I'm a broken record on stuff like this. The fact of the matter is, the criminals' own statements are so egregious, that we don't even have to make up a conspiracy because they did it and they published it. So in violation of criminal conspiracy and racketeering laws,

they're the ones that actually admitted to it and let's go to the 20 F filing. For those of you not familiar with a 20 F filing, when a foreign company files with the United States Securities Exchange Commission, one of their filings is called a 20 F filing, and Biotech, the mRNA injection manufacturer for Pfizer makes the following statement in their 20 F filing. So let's just, let's just set up at the gate. This is them speaking. This is not David Martin. This is them speaking, I'm reading straight from their 20 F filing.

To our knowledge. There is no current precedent for an mRNA-based immunotherapy, such as the type we are developing, being approved for sale by the FDA, the European Commission or any other regulatory agency elsewhere in the world. Although we expect to submit BLAs (which is the biologics license for mRNA-based product candidates in the United States and in the European Union) mRNA therapies have been classified as Gene Therapy Medicinal Products. Other jurisdictions may consider our mRNA-based product candidates to be new drugs, but not biologics or gene therapy, or medicinal products and require different marketing applications. Securing regulatory approval requires submission of extensive preclinical and clinical data and supporting information the various regulatory authorities for each therapeutic indication to establish the product's candidate safety and efficacy."

Listen, I read it straight out of their filing. When I say that this is not a public health vaccine, but this is a computer generated synthetic chimeric alternative to the virulence factor of SARS co V, which is exactly, exactly what it is. This is actually not Dave's theory. This is the reality that says we are being subjected to a perpetual addiction to a known pathogen and toxic agent. And the reason why Anthony Fauci is now advocating for the next round of boosters to be followed by the next round of boosters, is until we actually achieve the stated goal, which is a 15% population reduction, which I don't know if you do the math quick in your head, but **that's about 800 million people dead**. Until we get there. We will be recommending this injection to harm, maim, kill, murder, and sterilize humanity.

**Stew Peters:** To murder people. To murder people to prevent them from procreating. To alter their image of God their God given DNA and to make them worship a new master.

**Dr. David Martin:** Well, and the fact of the matter is, it's their words, not mine. They're the ones that said it. And by the way, it's important to realize that that wonderful thing about SARS cov 2 chimeric viruses that I read from the Code of Federal Regulations, that little thing called the Federal select agent program, that little thing called the Department of Health and Human Services and USDA agents and toxins program, that thing that I read, mysteriously had SARS co2 fragments listed as scheduled pathogens in April of 2020. Stew, do remember in February of 2020 we allegedly had a novel pathogen that we didn't know anything about? Remember, we just invented the thing. And we started filing patents for injections for the thing before we actually knew anything about it. So those wonderful days back in our prescience years where we could anticipate a pathogens emergence before it actually happened, and then build operation

warp speed in September before the first accorded evidence of the disease in December of that year, all of the wonderful things that we have unfolding around us. Somehow or another in April of 2020, we had the ability to know that there was going to be SARS Cov2 virulence factors added to a schedule of toxins before we even had a Moderna or Pfizer shot, except we had already transferred those things in November of 2019, under a material transfer agreement to make sure that we had an injection for a pathogen before we had an outbreak of said pathogen.

This is just clear evidence of the fact that this entire campaign of terror, which is what we need to be calling it, this is domestic terrorism. And this is international terrorism. This is bioterrorism writ large. And those acts were willfully and Premeditatedly perpetrated on the population. And to date the population has had not one, not Ron DeSantis, nobody in Florida, no attorney general, no governor, not a single person who has been willing to take on the crime. Not one.

**Stew Peters:** Disgraceful. It's completely disgraceful. **These are not side effects. These are *intended* consequences.** (Dr. Martin: That's correct.) These are not experimental injections, stop calling them that. This is not an experiment. This is a well-thought-out meticulous plan to commit murder. on a large scale. This is intentionally designed. This was chimerically engineered by people who knew exactly what they were putting into these injections delivered with this mRNA technology. They know exactly what they're doing. These are not experimental, the clinical trial data, they didn't need that they didn't need it. Why? Because they knew what that was what was going to happen. They knew what they were going to do. And the reason there's no threshold for death, the reason why it's not alarming to anybody that only one percent has reported to VARS and 25,000 people are dead, **the reason why nobody's talking about it is because they know that and they have not achieved their goal yet!** That's minuscule in comparison to where they want to take us.

**Dr. David Martin:** That is exactly right. And what we already know is that if we look at the pseudouridine addition to the mRNA that was put into this injection, if we look at all of the data that we know is now part of the code that went into the mRNA shot, we know that **these things were done with the intention of making them a permanent resident in the organic system.** And by the way, when you hear B A 2 variant, which is now the latest campaign of terror, recognize something very clearly. This new variant is not an alteration of a natural mutation of any viral model.

This is what's happening. When we have human beings turning into perpetual spike protein manufacturing facilities, we will have variant upon variant upon variant and these are going to be coming from injected people who are allegedly coming down with COVID. **Dr. David Martin:** Well, and still, you know, we filed in Utah. We filed the federal case in Utah on March the third. It is the first federal case where we're taking on the root of this definitional question around the difference between a gene therapy and a vaccination. We filed in Utah because we wanted to in addition to the claims that we laid out in that case, we wanted to see the federal government trying to defend itself because it turns out in Utah, their defense is going to be an affirmative admission of felonies in the state of Utah.

**Stew Peters:** Criminal consequences.

**Dr. David Martin:** Criminal consequences for their response.

**Stew Peters:** Good. I can't get over what you just said. I mean the reality of that turning the human body into a bioweapons lab, a bioweapon manufacturing facility.

**Dr. David Martin:** That's correct.

**Stew Peters:** It's just the most eye-popping most truthful, cutting language that you can possibly use. If that doesn't wake people up, Dr. Martin I don't know what will.

It seems that every time someone such as myself attempts to encourage our Christian brothers and sisters to resist an unconstitutional or otherwise reprehensible government policy, we hear the retort, "What about Romans

Chapter 13? We Christians must submit to government. Any government. Read your Bible, and leave me alone." Or words to that effect.

No doubt, some who use this argument are sincere. They are only repeating what they have heard their pastor and other religious leaders say. On the other hand, let's be honest enough to admit that some who use this argument are just plain lazy, apathetic, and indifferent. And Romans 13 is their escape from responsibility. I suspect this is the much larger group, by the way.

Nevertheless, for the benefit of those who are sincere (but obviously misinformed), let's briefly examine Romans Chapter 13. I quote Romans Chapter 13, verses 1 through 7, from the Authorized King James text:

"Let every soul be subject unto the higher powers. For there is no power but of God: the powers that be are ordained of God. Whosoever therefore resisteth the power, resisteth the ordinance of God: and they that resist shall receive to themselves damnation. For rulers are not a terror to good works, but to the evil. Wilt thou then not be afraid of the power? do that which is good, and thou shalt have praise of the same: For he is the minister of God to thee for good. But if thou do that which is evil, be afraid; for he beareth not the sword in vain: for he is the minister of God, a revenger to execute wrath upon him that doeth evil. Wherefore ye must needs be subject, not only for wrath, but also for conscience sake. For this cause pay ye tribute also: for they are God's ministers, attending continually upon this very thing. Render therefore to all their dues: tribute to whom tribute is due; custom to whom custom; fear to whom fear; honor to whom honor."

Do our Christian friends who use these verses to teach that we should not oppose President Bush or any other political leader really believe that civil magistrates have unlimited authority to do anything they want without opposition? I doubt whether they truly believe that.

For example, what if our President decided to resurrect the old monarchical custom of *Jus Primae Noctis* (Law of First Night)? That was the old medieval custom when the king claimed the right to sleep with a subject's bride on the first night of their marriage. Would our sincere Christian brethren sheepishly say, "Romans Chapter 13 says we must submit to the government"? I think not. And would any of us respect any man who would submit to such a law?

So, there are limits to authority. A father has authority in his home, but does this give him power to abuse his wife and children? Of course not. An employer has authority on the job, but does this give him power to control the private lives of his employees? No. A pastor has overseer authority in the church, but does this give him power to tell employers in his church how to run their businesses? Of course not. All human authority is limited in nature. No man has unlimited authority over the lives of other men. (Lordship and Sovereignty is the exclusive domain of Jesus Christ.)

By the same token, a civil magistrate has authority in civil matters, but his

authority is limited and defined. Observe that Romans Chapter 13 clearly limits the authority of civil government by strictly defining its purpose: "For rulers are not a terror to good works, but to the evil . . . For he is the minister of God to thee for good . . . for he is the minister of God, a revenger to execute wrath upon him that doeth evil."

Notice that civil government must not be a "terror to good works." It has no power or authority to terrorize good works or good people. God never gave it that authority. And any government that oversteps that divine boundary has no divine authority or protection.

Civil government is a "minister of God to thee for good." It is not a minister of God for evil. Civil magistrates have a divine duty to "execute wrath upon him that doeth evil." They have no authority to execute wrath upon him that doeth good. None. Zilch. Zero. And anyone who says they do is lying. So, even in the midst of telling Christians to submit to civil authority, Romans Chapter 13 limits the power and reach of civil authority.

Did Moses violate God's principle of submission to authority when he killed the Egyptian taskmaster in defense of his fellow Hebrew? Did Elijah violate God's principle of submission to authority when he openly challenged Ahab and Jezebel? Did David violate God's principle of submission to authority when he refused to surrender to Saul's troops? Did Daniel violate God's principle of submission to authority when he disobeyed the king's law to not pray audibly to God? Did the three Hebrew children violate God's principle of submission to authority when they refused to bow to the image of the state? Did John the Baptist violate God's principle of submission to authority when he publicly scolded King Herod for his infidelity? Did Simon Peter and the other Apostles violate God's principle of submission to authority when they refused to stop preaching on the streets of Jerusalem? Did Paul violate God's principle of submission to authority when he refused to obey those authorities who demanded that he abandon his missionary work? In fact, Paul spent almost as much time in jail as he did out of jail.

Remember that every apostle of Christ (except John) was killed by hostile civil authorities opposed to their endeavors. Christians throughout church history were imprisoned, tortured, or killed by civil authorities of all stripes for refusing to submit to their various laws and prohibitions. Did all of these Christian martyrs violate God's principle of submission to authority?

So, even the great prophets, apostles, and writers of the Bible (including the writer of Romans Chapter 13) understood that human authority—even civil authority—is limited.

Plus, Paul makes it clear that our submission to civil authority must be predicated on more than fear of governmental retaliation. Notice, he said, "Wherefore ye must needs be subject, not only for wrath, but also for conscience sake." Meaning, our obedience to civil authority is more than just "because they said so." It is also a matter of conscience. This means we must think and reason for ourselves regarding the justness and rightness of our government's laws. Obedience is not automatic or robotic. It is a result of

both rational deliberation and moral approbation.

Therefore, there are times when civil authority may need to be resisted. Either governmental abuse of power or the violation of conscience (or both) could precipitate civil disobedience. Of course, how and when we decide to resist civil authority is an entirely separate issue. And I will reserve that discussion for another time.

Beyond that, we in the United States of America do not live under a monarchy. We have no king. There is no single governing official in this country. America's "supreme Law" does not rest with any man or any group of men. America's "supreme Law" does not rest with the President, the Congress, or even the Supreme Court. In America, the U.S. Constitution is the "supreme Law of the Land." Under our laws, every governing official publicly promises to submit to the Constitution of the United States. Do readers understand the significance of this distinction? I hope so.

This means that in America the "higher powers" are not the men who occupy elected office, they are the tenets and principles set forth in the U.S. Constitution. Under our laws and form of government, it is the duty of every citizen, including our elected officials, to obey the U.S. Constitution. Therefore, this is how Romans Chapter 13 reads to Americans:

"Let every soul be subject unto the [U.S. Constitution.] For there is no [Constitution] but of God: the [Constitution] that be [is] ordained of God. Whosoever therefore resisteth the [Constitution], resisteth the ordinance of God: and they that resist shall receive to themselves damnation. For [the Constitution is] not a terror to good works, but to the evil. Wilt thou then not be afraid of the [Constitution]? do that which is good, and thou shalt have praise of the same: For [the Constitution] is the minister of God to thee for good. But if thou do that which is evil, be afraid; for [the Constitution] beareth not the sword in vain: for [the Constitution] is the minister of God, a revenger to execute wrath upon him that doeth evil. Wherefore ye must needs be subject, not only for wrath, but also for conscience sake. For this cause pay ye tribute also: for [the Constitution is] God's minister, attending continually upon this very thing. Render therefore to all their dues: tribute to whom tribute is due; custom to whom custom; fear to whom fear; honor to whom honor."

Dear Christian friend, the above is exactly the proper understanding of our responsibility to civil authority in these United States, as per the teaching of Romans Chapter 13.

Furthermore, Christians, above all people, should desire that their elected representatives submit to the Constitution, because it is constitutional government that has done more to protect Christian liberty than any governing document ever devised by man. As I have noted before in this column (See: [http://www.chuckbaldwinlive.com/c2005/cbarchive\\_20050630.html](http://www.chuckbaldwinlive.com/c2005/cbarchive_20050630.html) ), Biblical principles form the foundation of all three of America's founding documents: The Declaration of Independence, The U.S. Constitution, and The Bill of Rights.

As a result, Christians in America (for the most part) have not had to face the painful decision to “obey God rather than men” and defy their civil authorities.

The problem in America today is that we have allowed our political leaders to violate their oaths of office and to ignore, and blatantly disobey, the “supreme Law of the Land,” the U.S. Constitution. Therefore, if we truly believe Romans Chapter 13, we will insist and demand that our civil magistrates submit to the U.S. Constitution.

Now, how many of us Christians are going to truly obey Romans Chapter 13?
