
<u>The Coronavirus by Bill Hughes.</u> <u>Chapter 5. Ultimate Goals</u>

After the Reformation, literacy flourished, economic principles were articulated, and entire nations rose out of poverty. This produced a thriving middle class for the first time in human history." 'Understanding the Culture: A survey of Social Engagement', Jeff Myers. The Reformation brought about a flourishing middle class made of artisans, welders, printers, and the like.

Before the Reformation, all the Papal hierarchy had to do was control the king, or the baron, or the land owner. If he was controlled, then it would be easy to control the illiterate serfs and peasants. With the rise of the Reformation and the middle class, people began thinking more for themselves, independent of lords and barons, making a way for themselves and their families. The middle class made it much more difficult to control the populace because these people would think for themselves and the papacy did not want this! In order to bring the world back under Rome's sway, the middle class thinking people must be reduced and finally eliminated in Rome's plan. Civil and religious liberty was virtually an unknown commodity during the Dark Ages of Papal tyranny. When it came to deciding matters of faith, however, Luther found both to be deeply flawed and untrustworthy....

"With the help of the printing press, this 16th century protest against corruption in the Catholic Church would drastically change the course of Christianity — and history itself. In the process, Luther laid bare the scandal of Christendom: a political society that preserved spiritual unity through coercion and violence. Dissent from orthodoxy was outlawed; heresy was rooted out and punished by fire and sword. The papal bull of 1520 excommunicating Luther from the Catholic Church, for example, accused him of promoting 41 heresies and "pestiferous errors." One of the alleged errors was his view that "the burning of heretics is against the will of the Holy Spirit." Luther offers his fullest treatment of these issues in Secular Authority where he sharply distinguished the aims of church and state, limiting the reach of government to preserving life and property... Other reformers sought a radical separation of church and state, a concept that Luther ultimately rejected. Others went further in defending the rights of all religious believers, even heretics and non-believers, in civic and political life.... In the 18th century, the United States became the first nation to enshrine in its constitution the Protestant conception of the rights of conscience. James Madison, the mind behind the First Amendment, was inspired by Luther's achievement. In a letter to F.L. Schaeffer, dated 1821, Madison explained that the American model of religious liberty "illustrates the excellence of a system which, by a due distinction, to which the genius and courage of Luther led the way, between what is due to Caesar and what is due God, best promotes the discharge of both obligations." 'National Geographic', Joseph Loconte, Ph.D., October 27, 2017

By distinguishing between duties to God and duties to man, Luther paved the way to church state separation, the inherent rights of man to civil and religious freedom, and paved the way for the grand experiment called America!! 

What has been the story from day one in this coronavirus conundrum? The story has been thus, In the public mind, the origin story of coronavirus seems well fixed: in late 2019 someone at the now world-famous Huanan seafood market in Wuhan was infected with a virus from an animal. The rest is part of an awful history still in the making, with Covid-19 spreading from that first cluster in the capital of China's Hubei province to a pandemic that has killed about 350,000 people so far (to the time this article was written0.

December 31-January 11, 2020

On December 31 last year, China alerted the WHO to several cases of unusual pneumonia in Wuhan, a city of 11 million people. The virus was unknown. Several of those infected worked at the city's Huanan Seafood Wholesale

Market, which was shut down on January 1. As health experts worked to identify the virus amid growing alarm, the number of infections exceeded 40.

On January 5, Chinese officials ruled out the possibility that this was a recurrence of the severe acute respiratory syndrome (SARS) virus — an illness that originated in China and killed more than 770 people worldwide in 2002-2003.

On January 7, officials announced they had identified a new virus, according to the WHO. The novel virus was named 2019-nCoV and was identified as belonging to the coronavirus family, which includes SARS and the common cold.

On January 11, China announced its first death from the virus, a 61-year-old man who had purchased goods from the seafood market. Treatment did not improve his symptoms after he was admitted to hospital and he died of heart failure on the evening of January 9.

January 13 - 19, 2020

The WHO reported on January 13 a case in Thailand, the first outside of China, in a woman who had arrived from Wuhan.

On January 17, as a second death was reported in Wuhan, health authorities in the US announced that three airports would start screening passengers arriving from the city. Authorities in the US, Nepal, France, Australia, Malaysia, Singapore, South Korea, Vietnam and Taiwan confirmed cases over the following days.

January 20 - 26, 2020

On January 20, China reported a third death and more than 200 infections, with cases also reported outside Hubei province including in Beijing, Shanghai and Shenzhen. Meanwhile, a Chinese expert on infectious diseases confirmed human-to-human transmission to state broadcaster CCTV, raising fears of a major outbreak as millions travelled for the Lunar New Year holiday. The cities of Wuhan, Xiantao and Chibi in Hubei province were placed under effective quarantine on January 23 as air and rail departures were suspended. By the end of the week, more areas were placed under lockdown affecting a total of 56 million people. The WHO said that the outbreak did not yet constitute a public emergency of international concern and there was "no evidence" of the virus spreading between humans outside of China.

January 27 - February 2, 2020

On January 30, the WHO declared the coronavirus a global emergency as the death toll in China jumped to 170, with 7,711 cases reported in the country, where the virus had spread to all 31 provinces. By the end of the week, China reported 304 deaths amid 14,380 infections. Within a few days, new cases were confirmed in India, Philippines, Russia, Spain, Sweden and the United Kingdom, Australia, Canada, Germany, Japan, Singapore, the US, the UAE and Vietnam.

On February 2, the Philippines reported the first death outside China, the

victim being a Chinese man from Wuhan, the capital of Hubei province where the new coronavirus was detected in late 2019.

March 23 - 29, 2020

In the US, the White House and Senate leaders of both parties struck an agreement on March 25 on a sweeping \$2 trillion measure to aid workers, businesses and a healthcare system strained by pandemic. By the end of the week, the US accounted for the highest number of coronavirus infections in the world, recording more than 124,000 cases and 2,000 deaths, more than double the figure two days before. Meanwhile, as the number of cases worldwide surpassed 600,000, with more than 27,000 deaths on March 27, India and South Africa joined the countries to impose lockdowns. Kenya, Kazakhstan and Honduras reported their first deaths, while Johnson announced he had tested positive. In Europe, Spain recorded 838 new coronavirus deaths over the previous 24 hours on March 29, marking the country's highest daily jump in fatalities. The country was now second only to Italy where the death toll shot past 10,000 with 889 new deaths. (taken from Aljazeera, May 18, 2020)

"Dr. Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases, warned members of the incoming Trump administration in January 2017 about the inevitability of a "surprise outbreak" of a new disease. He said at the time that the US needed to do more to prepare. "There is no question that there will be a challenge to the coming administration in the arena of infectious diseases," Fauci said during a speech at Georgetown University, adding, "The thing we're extraordinarily confident about is that we're going to see this in the next few years." Business Insider, April 13, 2020

How did Fauci know this? How did he know there would be a pandemic during the Trump administration? Isn't Fauci a doctor? He sounds more like a prophet., "The thing we're extraordinarily confident about is that we're going to see this in the next few years." Business Insider, April 13, 2020

The following two statements shed on light on how Fauci could be so sure that a pandemic would strike during the Trump administration. "Dr. Anthony Fauci, a member of the coronavirus task force, had previously backed funding for a controversial lab in Wuhan, China, that has been studying the coronavirus in bats, reports said. Fauci's National Institute of Allergy and Infectious Diseases had shelled out a total of \$7.4 million to the Wuhan Institute of Virology lab — which has become the focus of theories about the origin of COVID-19, according to Newsweek. The National Institutes of Health, which oversees the NIAID, shut down all funding to the lab last week. "At this time, NIH does not believe that the current project outcomes align with the program goals and agency priorities," a deputy director at the agency wrote

in a letter obtained by Politico. There is "increasing confidence" among officials in the Trump administration that the Wuhan Institute of Virology lab is the original site of the virus. A report by Fox News said embassy officials warned in January 2018 about inadequate safety there. *The NIH defended its funding of the lab in a statement to Newsweek.*" April 29, 2020, New York Post.

Fauci's organization, the National Institute of Allergy and Infectious Diseases, sent 7.4 million dollars to the Wuhan laboratory in China, knowing full well that they were studying the coronavirus in bats. If his organization sent 7.4 million dollars to the Wuhan lab, then obviously Fauci was backing the research to the hilt. He not only knew of the experimenting, but backed it with millions of dollars. Fauci also believes in the golden rule. The one who dishes out the dough makes the rules! If Fauci was doling out 7.4 million, would it be safe to say that, he being a medical expert in infectious disease, was also part of what went on at Wuhan? The writing on the wall says yes!! This information is shocking, tying Anthony Fauci to Wuhan and the coronavirus.

The final comment from Newsweek magazine goes even further. "Dr. Anthony Fauci is an adviser to President Donald Trump and something of an American folk hero for his steady, calm leadership during the pandemic crisis. At least one poll shows that Americans trust Fauci more than Trump on the coronavirus pandemic-and few scientists are portrayed on TV by Brad Pitt. But just last year, the National Institute for Allergy and Infectious Diseases, the organization led by Dr. Fauci, funded scientists at the Wuhan Institute of Virology and other institutions for work on gain-of-function research on bat coronaviruses. In 2019, with the backing of NIAID, the National Institutes of Health committed \$3.7 million over six years for research that included some gain-of-function work. The program followed another \$3.7 million, 5-year project for collecting and studying bat coronaviruses, which ended in 2019, bringing the total to \$7.4 million. Many scientists have criticized gain of function research, which involves manipulating viruses in the lab to explore their potential for infecting humans, because it creates a risk of starting a pandemic from accidental release.

SARS-CoV-2, the virus now causing a global pandemic, is believed to have originated in bats. *U.S. intelligence, after originally asserting that the coronavirus had occurred naturally, conceded last month that the pandemic may have originated in a leak from the Wuhan lab.* (At this point most scientists say it's possible—but not likely—that the pandemic virus was engineered or manipulated.) Dr. Fauci did not respond to Newsweek's requests for comment. NIH responded with a statement that said in part: "Most emerging human viruses come from wildlife, and these represent a significant threat to public health and biosecurity in the US and globally, as demonstrated by the SARS epidemic of 2002-03, and the current COVID-19 pandemic.... scientific research indicates that there is no evidence that suggests the virus was created in a laboratory. The NIH research consisted of two parts. The first part began in 2014 and involved surveillance of bat coronaviruses, and had a budget of \$3.7 million. The program funded Shi Zheng-Li, a virologist at the Wuhan lab, and other researchers to investigate and catalogue bat

coronaviruses in the wild. This part of the project was completed in 2019." Newsweek, April 28, 2020

Researching viruses in laboratories is highly criticized by scientists because of the possibility of the virus being leaked and causing a pandemic. This is exactly what happened in Wuhan. Dr. Fauci's comments in 2017 would indicate that he knew that would be the case and warned it was coming!!! Speaker: Ladies and gentlemen, please stand on your feet and greet Dr. David Martin. (Applause)

David Martin: Thank you very much. Mikki (Willis), you would you stand up, please? Many of you know me because of the work and the brilliance of this man and his team. And well, that's interesting. What you don't know, is the speech that I'm about to give is because this man is not just behind the camera. He's actually a brother. And what he did to me a few months ago was he called me and he said, "You know what?" He goes, "You presented all the facts. You've been out there in front of this thing before it was a thing." And he goes, "But there's something missing. And there's something that's missing is your humanity. What happens when I sit close to you is one thing. And what happens when you're on a stage or on a camera in an interview is a different thing." And he goes, "You need to bring the man into this presentation." So the presentation that you're hearing today is because I have a brother who holds me accountable. Mikki, Thank you. (Applause)

COVID-19 and **SARS COv2** was a coup d'etat. And let me be precise about what I mean by that. Sedition in the United States is actually defined very simply, by when any act is done by a conspiring party or group of parties, that its intent is to disrupt or interrupt or overtake the government of a state or a country. And under 18 US Code, the act of sedition was in fact, a coup d'etat

to ensure that there would not be a democracy in 2018. Okay, and I'm going to present across the next few minutes the evidence of that. And I'm going to end my presentation with a challenge to you. Because during my presentation, the 30 minutes that I have, is going to cost two children their life because of the inaction of every attorney general in America, because of the inaction of every US attorney, and because of the inaction of every governor in this country. But my grandfather said, Never attribute to malevolence what is ignorance. So in the next 30 minutes, I'm giving every elected official the opportunity to do the right thing. And after 30 minutes, I'm not going to give them that opportunity again. (Applause) So you got Mr. Nice Guy for 30 minutes.

Next. Now, most of you don't know the details of all of the elements. And the good news is I'm going to flip through these slides very quickly because the end of the story is the important part of the story. But for those of you who don't know, COVID is a direct result of HIV Inc. HIV Inc. was founded in 1984. Anthony Fauci was the chief architect of HIV Inc. And his goal was to use sexuality, and specifically homosexuality, as a way to indoctrinate humanity into the acceptance of a universal vaccine mandate. Now, interestingly enough, most of us didn't take the bait. And the reason we didn't is because we didn't live the lifestyles that were associated with HIV in 1984. But cunningly, by 1986, Anthony Fauci and his team at NIAID (National Institute of Allergy and Infectious Diseases) and his minions at the CDC had convinced each and every one of us that maybe we've been in a car accident, maybe we would get a transfusion, and maybe we would get AIDS, which was the justification for a universal HIV vaccine in 1984. It's gonna get nasty because I'm going to show you some real images from 1984 just to let you see that what I'm saying is not my imagination.

But in 1984, something happened. People realized that to accept a universal vaccine, we needed to create a liability shield for the manufacturers of those vaccines. And from 1984 to 1986. We actually built the first-ever product immunity in the United States, which allowed manufacturers to kill people with intent. And you heard what I just said, kill people with intent. Anthony Fauci was quoted himself as saying that the ultimate killer of pharmaceutical interventions with vaccines was the smallpox vaccine, which killed one in every 100,000 and injured or maimed one in every 10,000. Did you hear what I just said? Killed one in 100,000, maimed one in 10,000. And that was something that he thought he could turn into a universal vaccine for HIV in 1986. I don't know what an acceptable death rate is for you people. But an acceptable death rate for any product, anywhere in the history of humanity in my definition, is zero! (Applause)

But then, a little dirty secret came along. Somebody at the NIH (National Institutes of Health) said, "Hey, Tony, Cool your jets baby. We have this drug called AZT. And we don't want a vaccine too quickly. We want to kill people with AIDS with AZT. So let's run the clock on it in the state of North Carolina...". By the way, if you're from North Carolina, or you've done anything in North Carolina, you got tar on your heels and blood on your hands. Because the state of North Carolina since 1986 has been brought to you by HIV Inc.



That's a bummer. I think I just lost the elected officials in North Carolina. Shoot. I couldn't even make it through a presentation.

UNC-Chapel Hill began the weaponization of Coronavirus in 1986. But by 1996 Anthony Fauci had a little plan. Coronavirus, as a model, has a very interesting set of attractive attributes, which include this very interesting thing called a spike protein and a couple of other binding sites where the virus allegedly binds to the outside of the cell. And it turns out that Ralph Baric (a professor) at the University of North Carolina Chapel Hill, was the very first person to figure out how to take a pathogen, which used to be an infection of the gut, gastroenteritis. For over 30 years Coronavirus was gastroenteritis. But Ralph Baric figured out how to weaponize it and not weaponize the virus, weaponize the spike protein. And he was the one that figured out how to make a thing that used to hit your gut, hit your heart. That was gain of function ladies and gentlemen, the thing that we never did, allegedly. He did it! And in 1996, he received a grant and then a series of grants in 1999, by Anthony Fauci to actually weaponize the Coronavirus spike protein so it could be used as a vaccine vector with the idea that it would be the next HIV vaccine.

That's when I started watching this. I've been a locust-eating prophet in the wilderness. (Laughter) Because my first briefing on this was in 1999. My first intelligence briefing on this was in 2003, in a published document that I have sitting on my desk to remind me that sometimes being right isn't as good as being effective. Turns out I was right in 2003. And unfortunately, I wasn't effective.

But Fauci ran into another problem. And in 1999 to 2002, and patented by the University of North Carolina Chapel Hill, and conveniently in the fall of 2018, do you all remember the big Coronavirus outbreak of 2018? No, that's because there wasn't one. But in an unprecedented move, the University of

North Carolina Chapel Hill was forced to sign their SARS vaccine patent from UNC-Chapel Hill back to NIH. By the way that hasn't been done. But they did it in the fall of 2018. Does it feel like they were preparing for something?

Next slide. Do not read this slide. Because I used to hate professors who put reading charts and eye exams on slides. Don't read it with any luck, Clay Clark can figure out how to make all of this presentation available to you. And I hope he does because that's what it's for. But in 1984, we created the vaccine nightmare, and we let Anthony Fauci have \$191 billion. And you heard the number, right, billion. We've been told about \$3.7 million going to China, and we're supposed to be upset about that. How about \$191 billion of your taxpayer money that has gone to weaponize nature against humans? 191 billion, and let's do the little walk-through, shall we? 1984 we invent the vaccines for HIV, which led to death and permanent disability to over 50% of the participants. But that was okay because they were gay. That was okay. It gets worse. Okay. 2001 you remember the anthrax scare the domestic terrorism scare? Did anybody know that the US military in the spring of 2001 ordered 300 million doses of Ciprofloxacin? 300 million doses. Now we have a pretty compelling army in this country. But with all due respect, 300 million sounds like every citizen in America, it doesn't sound like every member of the US military. And how is it that at least five months before anthrax was released, we ordered 300 million doses of the treatment called Ciprofloxacin? And from — oh that's right — a German company called Bear.

That's by the way when I started busting these stories because it turns out that this wasn't the only pathogen that was being developed by the Department of Defense. And it was interesting because in the early 2000s, I started seeing Coronavirus show up in a bunch of DARPA contracts and a bunch of DOD contracts and I'm sitting there going, why would we be doing that? Why would we be taking a thing which was for dogs and porcine — that's pigs by the way, that's a scientific term for pigs. Think bacon and you got it. Pigs and various other vertebrates? Why would we suddenly be trying to weaponize that and make it hit human lung epithelial cells and human cardiac cells? Why would we be doing that? And why would the Defense Department be doing that? Is that where you expect to go to kind of get your kind of basic treatment programs? NO!! And you don't go there? Because it sounds like a weapon system if it's being funded by billions of dollars of Defense Department black contracts, doesn't it? Or is that Dave the conspiracy theorist?

Well, let's jump into my favorite 2016 protocol, the <u>AMP (Antibody Mediated Prevention) protocol</u>. The AMP protocol has a line that I absolutely love. This was when we decided to let the University of North Carolina Chapel Hill develop the HIV vaccine. And it turns out that read what they said about this protocol, it will take place in sites, 24 sites in Brazil, Peru, and the United States and will enroll 2700 men and transgender people who have sex with men. What?! That's by the way straight out of the protocol.

If you don't believe what I say about the fact that Fauci has no concern for human life, but is more than happy to kill people who most people think shouldn't live anyhow, guess what happens? We start introducing the camel's nose under the tent and we start saying it's okay to kill people in the advancement of science. Now listen, people listen carefully. I am not

advocating for any lifestyle. But what I am saying is that when you've decided that you're playing God and that there is a person by any designation, that doesn't deserve to live, you left humanity! (Applause) Period! If any of you see my wife, you know, I'm very heterosexual and very happy. (Laughter) But that doesn't justify making a determination that somebody who doesn't share my values is worth killing in the name of HIV Inc. (Applause) Let's be clear on that. And then 2016 2019. And by the way, look at 2019, the hepatitis C vaccine, which guess what has to do with yet another sexual context story that they tried to turn into, they were killing people that are promiscuous, and usually gay and promiscuous, so we don't care about that. I'd love for some of the bleeding hearts left to actually realize that they're the ones celebrating the execution of the people who they allegedly represent. I think that would be a very interesting proposition. Because maybe somewhere along the line, we should actually go back to 1984. And look at the ghost of Anthony Fauci in this slide, by the way, if you see this slide that's on the screen, what you'll see is 1984 Anthony Fauci, no kidding. That's what he looked like in 1984. He still looked like that center from the high school basketball team.

What?! I'm going to tell you if I had to bet on a basketball team, and I knew that Anthony Fauci was the captain of that team in high school, I bet against him. And guess what, I'd bet against him now, too, because the dirty little secret is he actually made the statement, "it is quite possible. In fact, it's invariable that we will develop a vaccine for AIDS." Now, you know, sometimes there are things called Freudian slips, people say things and they didn't mean to say it. So I want to give him credit. He probably misspoke. He probably meant to say it's inevitable that we'll do it. But he didn't say that. He said, it's invariable that we do it. And it turns out that if you look at the definition of the word invariable, you know what it means? "I'm never going to stop doing a thing". Ah oh! You think we're talking about a COVID vaccine right now. No. We're still talking about Anthony Fauci's fantasy of an AIDS vaccine. Don't make a mistake by being fooled.

Next slide. Here's the problem. 1984. He had an epic fail. He tried to make an AIDS vaccine, it didn't work. In 2005 he tried to do H1N1, an epic fail, people died, it didn't work, people didn't roll up their sleeves, epic fail. And then a bummer of an opportunity came along. In 2018 we actually did have an influenza pandemic. We had a lot of people that died. And guess what we didn't do. We didn't shut down countries. We didn't shut down borders. We didn't shut down schools or churches or anything else. We just let people die. And it was seen inside of NIAID as a lost opportunity. Dead people was a lost opportunity. So what he did was he figured out something and he gave the University of North Carolina Chapel Hill a grant to create a pathogen. So that we could actually get, and I'm quoting, "the public to accept the need for a pan coronavirus vaccine. We need the media to create the hype to get to the real issues. We need to use that hype to our advantage. Investors will follow if they see profit at the end of the process."



That's a quote, National Academy of Sciences, Peter Daszak 2015, published in February 2016, Proceedings of the National Academy of Sciences. This was not a public health problem. This was a biowarfare act of domestic terrorism meted out on the citizens of the United States and the people of the world. And it was not a lab leak from China. It was not a lab leak from anywhere. It was an intentional weaponization of the spike protein, and it is murder and we will call it what it is. (Applause) It was murder then, and it's premeditated murder. And we have to be clear on the fact. In fact, never use the word vaccine again. That's like saying that a gun is a propellant of copper. No, it isn't. It's a gun. Call it what it is. Next slide.

And here's where it gets nasty. You guys know the guy on the right. What you don't know is the guy on the left. And here's the story you don't know about the guy on the left. The guy on the left is Alex Azar. Now, what you don't know about the guy on the left is the guy in the portrait further to the left is even a bigger problem, Henry Waxman. Henry Waxman the patron saint of caring about health, who was the one that made sure every pharmaceutical company got a shield of liability so they could never be held accountable. That Henry Waxman had a very interesting guy appointed by Trump in 2017, Alex Azar, Director of the Department of Health and Human Services. What Trump didn't know, what you didn't know, what most of America didn't know was Alex Azar was an executive, not a physician, an executive at Eli Lilly. And at the time of his appointment, he happened to be under investigation for pricefixing diabetes drugs in Mexico. Hmm hmm. In fact, during his now found to be collusion and racketeering and price fixing an antitrust violation, which turned out to be, held to be, exactly what I just said. While he was actually trying to deflect attention from the racketeering that he was doing by pricefixing insulin in Mexico, he actually made President Trump sign an order. That was the execution order for Americans. And President Trump was advised by appointed individuals who never told him the facts. This ladies and gentlemen was treason. This was treason. And anybody who wants to point the

finger at Donald Trump, the best you can do is say he was subjected to corruption and maliciousness and treason and traders within his circle. That's true. But when he signed this, he did not know the cost. He did not know. And the persons who did know was the lobby, the pharma lobby, the single largest donor in US history to political campaigns. They were the puppets that actually put that paper in front of Donald Trump. And Alex Azar was the executive responsible for the death and destruction of America. And you have not even heard his name. Because criminals like to put other people upfront. Well, they hide in the shadows. Well, guess what, we're not going to let happen today. A lobbyist turned executive, turned architect of oh my gosh, under the Bush administration, Alex Azar was the one who also came up with the prep Act, which actually shielded companies from liability in the event of a national emergency. Alex Azar is the perpetrator of the largest genocide this country has ever seen. And you do not know his name. But that just changed today. (Applause)

Oops, that was my out-loud voice. And it turns out, he's the boss of Anthony Fauci. He's the boss of CDC. He's the boss of NIAID. He's the boss of NIH (National Institutes of Health). He's the boss of the FDA. And guess what? He's the first guy that the FBI should cuff, lock up, and put in prison for the rest of his life! (Applause) That's our target. And don't think I'm actually advocating justice for the sake of justice. I'm advocating justice, because the minute we actually have the first felony conviction, the first time the emergency use authorization vanishes, because it turns out the emergency use authorization cannot stand if the basis of it was a felony. And that's written into the law. We have one focus. We have one silver bullet. And I am waiting for one AG (Attorney General) in this country to stand up and be accountable for the lives that are being lost because well, I'm talking, two children died because they're being murdered by a collusion racket. Which is like having Al Capone drive through the streets of Chicago and shoot into a school. You wouldn't sit for that but you have sat for this. Well, guess what? Not after this. From now on every hour that you do not follow the instructions I have at the end of this speech, for every hour that you don't take action, another two children die. And I want you to go to bed tonight asking yourself, did you pay attention? Or Are you cool with two kids dying every hour? I want you to sleep on that. I want you to sleep with that. Because on my watch, that ain't gonna happen.

Now I may be David and I may have a couple of river stones, which I'm going to share with you. And we got a Goliath that we got to work with. That's okay. But let's do the next slide because I got a punch line. And I'm going to get on schedule, in fact ahead of schedule. I'm going to end early to respect the next speakers. So here we go. That slide. Here's the deal, guys, you're going to share this slide, so I don't have to talk about it right? We're going to figure out a way to share the slide. Awesome. So you don't, I don't have to talk about it. Because I do have to talk about this.

There are two websites right now by any grace of God in the next five minutes or 10 minutes or hour, there's gonna be 100 websites like this, because what I conveniently did for every attorney general for every US Attorney for every law enforcement agent in this country, what I did was I went ahead and

drafted the indictment notice. (Applause) The United States of America v. And let's read it out because that's all the time I have.

We are going to do the following, you're going to go to that website, DavidMartin.world or fullyliveacademy.com, there's a button that says AG document, you are going to print that document and you're going to deliver it to every US attorney general in every state, you're going to deliver it to every US attorney, you are going to put them on notice that from this day forward, and literally from this minute forward, every death is on their hands, because they can do something about it. And they have chosen now four times in four meetings, they have chosen to say, "Dave, this is a political, not a legal issue." And that's a quote from AGs offices. Make it a legal issue. And if they haven't made it a legal issue, if you haven't heard that an AG met with me, make it a political issue next year. Because this is our country, these are our children, and we will not let them die on our watch. (Applause)

Ladies and gentlemen, we the people can do something. You now are entrusted with much. And to quote that beautiful narrative in the Gospels. When you have been entrusted with much even more is required. Guess what? I just gave you the river stones. There's an eight-count indictment, all felonies, all punishable by up to 99 years in prison, and up to \$100 million, fine. And, and I'm going to tell you today that anybody who works with me on this case has to agree to the following. All of the proceeds that we get from the collections of this lawsuit, and I mean, all of them are going to go to a Vaccine Injury Fund that does not require anyone to prove that the vaccine did anything. <u>COVID-19 mRNA Injections are Legally</u> <u>Not Vaccines! — By Dr. David E. Martin</u>

Transcript of David Martin's talk

(Dr. Martin:) January 11, 2021, at least got the date, right? We're not in December anymore.

Today, hey, by the way, thanks, everybody, for the last six weeks that that series has been shared a lot, we've gotten a lot of great feedback. So thank you, everybody, who has been a huge part of our six-week series on the integral accounting view of what's next. That's been a really wonderful experience. Today, we're diving back into some really important stuff. And there are a number of you who have been asking questions about the status of legal proceedings, and so forth. And, and today, I'm going to give give you a little window into a couple of the approaches that are going on in various lawsuits. We're not commenting specifically on lawsuits right now that are active and pending simply because that's just not an appropriate thing to do. Other than to say, there are active and pending cases.

But today is a really weird one, people. And I have to say, you know, back in the early 1990s, I was doing clinical trials at the University of Virginia medical school. And I happened to be working in a very controversial medical technology area called electromagnetic field therapy or EMF. And

historically, I mean, if you go back for decades, there's been all kinds of disputes around whether or not that technology works or not.

And I became very aware of 15 US Code Section 41, which is part of the Federal Trade Commission Act, that specifically has to do with advertising that a product or service can prevent, treat or cure human disease unless you possess competent, reliable scientific evidence, including when appropriate, well-controlled human clinical studies substantiating that the claims are true at the time they're made. So there's a rule under the Federal Trade Commission Act, and it has been used to shut down alternative medicine for years like you know, people who have been naturopaths, people who have been chiropractors, people who have been in any of the what are considered to be kind of alternative medical spaces have become very familiar with this, because it's the way the Federal Trade Commission shuts people down. confiscates materials, confiscates businesses, does some really egregious acts. And it occurred to me that no one seems to be talking about this when it comes to what is being promoted in the current regime!

And so, I thought, we're going to take a look into 15 US Code Section 41 today. And the reason for this is twofold. Number one is because it's important. Number two, is because I think that we need to call out a very important thing. So there's a part of the Federal Trade Commission Act, which also has to do with what's called deceptive labeling practices. It's when you use terms or phrases or words where you know that you are using them with an intent to deceive, deceptive medical practices. And so today, we're going to take apart a couple of the deceptive medical practices, and suggest that if any of you, and this is now a specific challenge, people, listen, we've been doing 39 of these videos.

Somebody who's watching this video knows an elected official, somebody watching this video knows a prosecutor, whether that's a US Attorney, whether that's an Attorney General in a state, somebody in the viewing of this video knows somebody who needs to listen to this video. And I'm going to really encourage you to share this, because it's actually super important. Listen, if this law can be applied to shut down people of goodwill, who are trying to help other people, it certainly should be equally applied when we know deceptive medical practices are being done in the name of public health. And we're going to get to that.

But Kim, let's start off with both of us worked in hospitals. Both of us worked in medical centers. As a condition of employment, you had to have shots, right?

(Kim:) Yeah, definitely had to have shots that have hep B and a few others. That was a bit way back in the day. But yeah, we had to have, all of us had to have as to be a nurse. You had to have shots done.

(Dr. Martin:) Yeah, I mean, at the Medical Center at the University of Virginia, you know, hep B was a standard. If you didn't have heb B, you know, you had no patient interaction. How about when you were in your own business?

(Kim:) No, not when I was running my own business, because I wasn't employed by a hospital. I did my own assessments of my own group of nurses. And we didn't have to because I was the boss.

(Dr. Martin:) Yeah. But there are people. I mean, let's be really clear. There are people for whom vaccines and various medical measures are a requirement for employment. And that's a really interesting problem where you get forced into doing something, and that made me think. Somethings troubled me. And the thing that's troubled me is that both Pfizer and Moderna have been promoting what they call a "vaccine".

Now, for those of you who don't really think about it, you have thought about it, because the public thinks that when you say vaccine, one of at least two things is happening. First is, whatever you're getting is going to keep you from being infected by some sort of pathogen. So that's assumption number one. Assumption number two, is that somehow or another, if you get that vaccine, somehow you're doing your public health bit to make sure that you don't transmit it to other people, right? Am I going out on a limb here? The word "vaccine" kind of means that.

And let's let's go back in history a little bit, shall we? Let's go back to 1905, to the very, very, very, very famous Jacobson case in Massachusetts (Jacobson v. Massachusetts Ref: https://en.wikipedia.org/wiki/Jacobson_v._Massachusetts), the Supreme Court 1905. And I'm going to read the quote, because I think it's important,

"This Court has more than once recognized as a fundamental principle, that persons and property are subjected to all kinds of restraints and burdens in order to secure the general comfort, health, and prosperity of a state."

So what the Supreme Court and Jacobson said was that the police powers the public health powers were legitimate if they secured the general comfort, health and prosperity of the state. That implies that the individual benefit is superseded by a collective benefit, that somehow or another, the individual is not the point when it comes to public health laws, it's about the community, which would then suggest that to meet a vaccine public health standard, and quite frankly, a vaccine public health definition, something about either you are immune from getting a pathogen or and potentially and, you are not going to transmit the pathogen, must be part of what lives inside that definition. That couldn't be more straightforward than the Supreme Court of the United States in 1905, which, by the way, happens to be a decision that I have yet to even meet many attorneys who have bothered reading it. They talk about vaccine litigation. But I haven't heard many that can actually quote the majority opinion out of Jacobson, which is a very dangerous problem that we have.

But here's where it gets more interesting. So when Moderna was started, and if you go back and look at their SEC filings, and we've gone through all their SEC filings, they make a point of saying that their technology is a gene therapy technology, gene therapy technology, you'll notice that they don't say vaccination, they actually say gene therapy technology. And it was set up to be a cancer treatment. So this is gene therapy, chemotherapy.

Now, let's just stop for a minute. Let's just ask the question. If Anthony Fauci got up and said to everybody, "Hey, we want you to take chemotherapy for the disease that you may or may not ever have." There wouldn't be a single person raising their hand, the prophylactic chemotherapy, you wouldn't be doing it. You know why you wouldn't be doing it? Because it's a dumb idea, that's why you wouldn't be doing it. And, States wouldn't be able to mandate it and employers wouldn't be able to mandate it, no employer would be able to mandate a chemotherapy for a disease that you don't have. That would not be a legal thing to do. But they called their technology, gene therapy technology. They made a big point of saying that this was not investigational new drugs, this was gene therapy technology. This belonged in the Center for Biologics, potentially even the CDRH, the Center for Device and Radiological Health, because let's think about what they actually do. And by the way, this is super important. All the references are going to be in this video on the YouTube channel. And I'm going to put a bunch of the references actually, in the comments section on Facebook Live so that you can go see this yourself.

But what they're doing is they're putting together a synthetic fragment of nucleic acid, it's not mRNA. It's not natural. It's not even a natural component of a fragment. It's a synthetic fragment, it's a technology embedded within a fat carrier, a peg carrier, and that is being introduced into the cell not to induce a immunity from infection with a SARS COVID virus, and it's not to block transmission of it. It's actually to lessen symptoms associated with the S1 spike protein, not even the virus itself. So it gets better and or worse, depending on your point of view. The fact of the matter is this thing is actually not a vaccination.

Now, why would I say it's not a vaccination? People go, "Dave? Why would you say it's not a vaccination?" Well, let's look at the legal standard for what a vaccination is. And let's start with the Center for Disease Control's own definitions, why not start with the people who run the racket?

Two important operative definitions: Immunity is protection from an infectious disease, protection from an infectious disease. If you are immune to a disease, you can be exposed to it without becoming infected. Now, by definition, neither Pfizer nor Moderna even claims that to be the case. That's straight-up, not their definition. So immunity, you can be exposed to a pathogen infectious disease without becoming infected. Not only is that not the case, we're going to get to this in a minute, but in their clinical trials, they specifically say they're not going to test that. So stay with me on that.

And then the CDC says a vaccine is a product that stimulates a person's immune system to produce immunity, see the definition above, to a specific disease protecting the person from that disease. And then it says vaccines are usually administered through needle injections, but also can be administered by mouth and sprayed in the nose. Now, that's the CDC.

So let's just stipulate for the sake of this conversation, that the CDC his own definition, and what Pfizer and Moderna are doing, do not match.

And by the way, you should be thinking somewhere in this video, hold on a

second. If this isn't a vaccine, why are they calling it a vaccine? That's a question. You should be thinking in your head because we're going to come to that in a second.

But I thought, okay, CDC, CDC is not the law. CDC is an expression of an agency, empowered by the law, but it's actually not the law. So why don't we actually look at the laws where vaccine has been defined? And it turns out, that's a much harder exercise than you would think. Because vaccine The term is actually not a legally defined term in an enormous number of statutes that govern vaccines, which is actually a really interesting thing. But let's look at some examples. And I just pulled a couple examples from the Iowa code. Vaccine, and I'm quoting means a specially prepared antigen administered to a person for the purpose of providing immunity.

Immunity once again, the operative definition, which is to say that when exposed to a pathogen, you are not susceptible. That's the Iowa code. How about Washington State? You know, the State that has been absolutely tyrannical and all of its interventions around Coronavirus, allegedly the birthplace of the US experience with Coronavirus, State of Washington. Vaccine legally defined term now, this is in the statute, means a preparation of a killed or attenuated living microorganism or fraction thereof, just Just stop right there, vaccine means a preparation of a killed or attenuated living microorganism. Stop right there. And mRNA synthetically developed by Moderna and Pfizer do not meet this definition.bOr a fraction thereof, it's not a fraction of a living thing or a killed thing, because it's neither living nor killed. They are explicitly synthetic gene therapies. They are not vaccines as defined by the statute that upon administration stimulates immunity. There we have it, again, that stimulates immunity, meaning that you do not get a thing when exposed to that pathogen, right? That protects us against disease and is approved by the Federal Food and Drug Administration and safe and effective. Now, that's the State of Washington statute. And by the way across the board, that's the definition of vaccine, which means immunity is a defined term vaccine is a defined term.

But here comes a really big problem. The big problem is that if we look at the clinical trials that were approved for what was called the SARS-CoV2 COVID-19 vaccine program under the operation warp speed, listen very carefully to what the primary endpoint is.

The primary endpoint is the prevention of symptomatic COVID-19 disease. Now, let's pause and unpack that starting with COVID 19 disease.

As you all know, if you've been watching this show at all, you know that in February, the World Health Organization, and the CDC and the Department of Health and Human Services made a very clear distinction. They wanted to make sure that COVID-19, which was a series of clinical symptoms, which included things like fever, muscle pain, aches, loss of smell, certain radiologic findings in the lungs, a whole host of things, there's a laundry list of things that all got subsumed within this thing called COVID-19, which by the way, has been now redefined as to pick which is pneumonia, influenza COVID, as a combined set of things so that we can catch more people allegedly dying of this thing. But COVID-19 disease is actually not a disease, it is a set of

symptoms.

And they were very clear on this, by the way. They tried to make a causal statement, they tried to say sorry, COV2 causes COVID-19. But then there was a tiny problem. Most of the people who tested positive using the RT PCR method had no clinical presentation, which means you can't make a causal statement. You can't say the virus causes a disease, because unfortunately, most people with a positive PCR test for a fragment of what was called SARS-CoV-2, didn't have any problem. In fact, well over 80% had no problem. Which then leads us to the question of, okay, so we can't say it's causal, but it's more problematic than this, the primary endpoint for the vaccine trial was actually not a vaccine endpoint.

A vaccine endpoint has to do with immunity. And a vaccine endpoint has to do with transmissibility. And neither of those were measured, and it gets worse.

And I'm quoting right now straight out of Moderna's own statement. "Key secondary endpoints include prevention of severe COVID-19 disease, and prevention of infection by SARS-CoV-2." But here comes a tiny little problem. By their own admission in their clinical study, it was and I'm quoting, "impractical to measure infection." That's right, you heard me correctly. It's impractical to measure infection. So there is no evidence inside the phase three clinical trials, that any of the gene therapy had anything to do with the infection or not of SARS-CoV-2.

You cannot have a vaccination. It's not under the legal definition of vaccination, you cannot have a vaccination. That is in fact, not meeting either an immune or a transmission standard. And their clinical trial was set up specifically so that it could not measure either of those things.

And then, let's quote, shall we, from *The New England Journal of Medicine*, and from *The Lancet*. And this is October, and this is December respectively. And I'm just going to go ahead and read this quote:

"At the time of this writing, no correlate of protection from SARS-CoV-2 has been established." (Ref: https://www.nejm.org/doi/full/10.1056/NEJMoa2028436)

Maybe you misheard what I just said. As of this writing, no correlative protection for SARS-CoV-2 has been established. In other words, not a shred of evidence from the clinical trials said anything about protection from infection with SARS-CoV-2, which means every single person who has value signaled their vaccination because they're doing their part not to be infected with SARS-CoV-2, and not to get COVID-19, newsflash, you have been violating the Federal Trade Commission Act by deceptive practices. You've been telling people that there is a protection that the data itself does not afford. But maybe that was just one report. So why don't I read from the second report? And I quote, and this is the Lancet and New England Journal of Medicine, quote,

"No existing vaccines have been shown to be effective against infection with any betacoronavirus, the family that includes SARS-CoV-2, which causes Covid-19." (Ref: https://www.nejm.org/doi/full/10.1056/NEJMe2034717)

People, this isn't my opinion, this is not me selectively choosing to take a spin on facts. This is in fact, fact. Which then begs the question, Kim. What would motivate Pfizer and Moderna and more importantly felonious Fauci, the unsavory, what would motivate them and CDC and others to lie to the American people about this being a vaccine, because vaccines in the ordinary course of the use of that term, invokes within the listener, a presumption of protection against infection, and protection against transmission, neither of which have been established at all? Why would they use the term vaccine?

And here's where we have to depart from the facts. And we have to go into conjecture because that's the only thing we have available to us. As recently as 2018, Moderna was insisting that they were not making vaccinations, they were insisting that this is gene therapy technology, and it was cutting edge and it was all this kind of nonsense. And suddenly, courtesy of SARS-CoV-2, it suddenly became a vaccine company. It wasn't a vaccine company before. It's not a vaccine company now, it's a gene therapy technology company with an unproven gene therapy. That's what it is.

So when asked to ask the question, okay, so why, why do we keep hearing about vaccines? Ah, well, here's the reason I think we keep hearing about vaccines. And once again, my opinion here, people, this is not based on information that I have readily available, but it is my opinion. I think that if Anthony Fauci if Moderna and Pfizer, and others, public health authorities around the country and around the world, actually called this gene therapy chemotherapy, number one, people wouldn't want to take it. And they wouldn't want to take it for a good reason. Because experimental gene therapy is a bad idea, no matter who it is, no matter what it is, no matter where it is. Experimental gene therapy should not be relentlessly and recklessly distributed to a population, that shouldn't happen. So that's number one.

But number two is the 1986 liability exclusion. And this is what I think it really is. See, as long as Mr. Alex M. Azhar, the director or the Secretary of Department of Health and Human Services, as long as Alex Azhar keeps the state of emergency going, as long as every governor and every mayor and every unelected official keeps the state of emergency going under emergency use authorization rules, liability is a shield that's afforded to people like Pfizer and Moderna and others. So they're making billions of dollars on the back of something for which they have no liability. But, if this was not a vaccine, then all a sudden the liability shield would vanish, because there is not a liability shield under the 1986 Act for a medical countermeasure that is gene therapy.

Which means we're probably having governors, and the Health and Human Services and CDC and others, maintaining the illusion of a state of emergency not because there's a state of emergency. They're maintaining it, because it maintains the illusion of the liability shield. Remember that if you suspended the state of emergency today, like, I don't know, if you're the governor of South Dakota, and you ever have anybody who remotely cares about this matter, listening to this video, lift the state of emergency because on the day you do it, RT PCR can't be used. Because RT PCR is not a diagnostic, it has never been approved, and it does not and cannot diagnose and treat a disease, which means every time Bloomberg, Gates Foundation and Zuckerberg

foundation COVID-19 dashboard reports that there is a another case of COVID-19 because of a positive RT PCR test, they are violating the 15 US code Federal Trade Commission Act. You cannot diagnose a thing that cannot diagnose the thing. That's a misrepresentation. That is a deceptive practice under the Federal Trade Commission Act. And they're liable for deceptive practices. Because it turns out, you do not have a waiver of liability under deceptive practices, even in a state of emergency.

So maybe the reason why they're calling it a vaccine is because they can count on the fact that neither you nor I will ever have this video, you and I will never do this independent inquiry you and I will never ask the question, is it possible that the entirety of what operation warp speed was, was nothing but propaganda? Which leads me to my conclusion.

Some of you know this, some of you don't. But operation warp speed has a middleman. And the middleman is a company called at ATI, a defense contractor out of North Carolina. And it turns out that that defense contractor is the one that clears the billions of dollars of orders for vaccines. By the CDC and by Pfizer! That's like asking a bank robber to investigate their own bank heist. It is beyond insane people. And it's time for each one of you not to just like this, not to just share this, but send it to law enforcement in your state, because somebody somewhere out there in these 50 states is going to actually care about following the law. (Mikki Willis:) Dr. Judy Mikovits has been called one of the most accomplished scientists of her generation. Her 1991 doctoral thesis revolutionized the treatment of HIV/Aids. At the height of her career, Dr. Mikovits published a blockbuster article in the journal, Science. (Mikki Willis:) And so what did they charge you with?


(Dr. Mikovits:) Nothing.

You know, they search my house without a warrant to literally terrorize my husband for five days. - (**Dr. Mikovits:**) Because if we don't stop this now we can not only forget our Republic and our freedom but we can forget humanity because we'll be killed by this agenda.
- (Mikki Willis:) So Anthony Fauci, the man who is heading the pandemic task force was involved in a cover-up?
- (**Dr. Mikovits:**) He directed the cover-up. And in fact, everybody else was paid off and paid off big time, millions of dollars in funding from Tony Fauci, Tony Fauci's organization National Institute of Allergy and Infectious Disease. (Mikki Willis:) How can a man who's giving, any person who's giving global advice for health, own a patent in the solution in the vaccine? Isn't that a conflict of interest, or shouldn't it be?

(**Dr. Mikovits:**) It *is* a conflict of interest. And in fact, this is one of the things that I've been saying and would like to say to President Trump, repeal the Bayh-Dole Act. (Bayh—Dole Act or Patent and Trademark Law Amendments Act (Pub. L. 96-517, December 12, 1980) is United States legislation dealing with inventions arising from federal government-funded research.

(From TV excerpt:) Bayh-Dole fundamentally changed the way universities approach technology transfer, and you can see that best in the statistics. Universities obtained 16 times as many patents today as they did in 1980. Now everybody's getting more patents but still, universities' share of all patents in the United States is more than five times greater than it was before Bayh-Dole. The situation has gotten so bad that one information technology industry official has publicly referred to universities as "crack addicts" driven by "small-minded tech transfer offices addicted to patents royalties".

(**Dr. Mikovits:**) That Act gave government workers the right to patent their discoveries, so to claim intellectual property for discoveries that the taxpayer paid for. Ever since that happened in the early eighties **it**

- destroyed science. And this allowed the development of those conflicts of interests. And this is the crime behind letting somebody like Bill Gates with billions of dollars nobody elected him he has no medical background, he has no expertise, but we let people like that have a voice in this country while we destroy the lives of millions of people.
- (**Bill Gates:**) Normalcy only returns when we've largely vaccinated the entire global population.
- (Mikki Willis:) If we activate mandatory vaccines globally, I imagine these people stand to make hundreds of billions of dollars that own the vaccines.
- (**Dr. Mikovits:**) And **they'll kill millions** as they already have with their vaccines. There is no vaccine currently on the schedule for any RNA virus that works.
- (Mikki Willis:) So I have to ask you, are you anti-vaccine?
- (**Dr. Mikovits:**) Oh absolutely not! I'm, in fact, vaccine is immune therapy just like interferon-alpha is immune therapy. So I'm not anti-vaccine. My job is to develop immune therapies, that's what vaccines are.
- (Mikki Willis:) Do you believe that this virus was created in a laboratory?
- (**Dr. Mikovits:**) I wouldn't use the word created, but you can't say naturally-occurring if it was by way of the laboratory. So it's very clear this virus was manipulated, this family of viruses was manipulated and studied in a laboratory where the animals were taken into the laboratory and this is what was released whether deliberate or not. That cannot be naturally-occurring. Somebody didn't go to a market, get a bat, the virus didn't jump directly to humans. That's not how it works. That's accelerated viral evolution. If it was a natural occurrence, it would take it up to 800 years to occur. This occurred from SARS one within a decade. That's not naturally occurring.
- (Mikki Willis:) And you have any ideas of where this occurred?
- (**Dr. Mikovits:**) Oh yeah. I'm sure it occurred between the North Carolina laboratories, Fort Detrick US Army Research Institute of infectious disease and the Wuhan laboratory.
- (TV announcer:) 3.7 million dollars flowed from the National Institutes of Health here in the U.S. to the Wuhan lab in China, the same lab where many people have said that this corona virus infection first originated. We also now know that NI-AID, the department associated with the National Institutes of Health, of which Dr. Anthony Fauci is in control, had already been conducting experiments with the Wuhan lab in the past in regard to corona virus. If Dr. Anthony Falci cannot be honest with the public about his connection to this lab, then Fauci has to go.
- (**Dr. Mikovits:**) In 1999 I was working in Fort Detrick, and my job was to teach Ebola how to infect human cells without killing them. Ebola couldn't infect human cells until we took it in the laboratories!

(Mikki Willis:) It's hard to ignore the death tolls. People have been dying and they are dying from this in quite alarming numbers. How do you reconcile that?

(**Dr. Mikovits:**) It's pretty easy when you see for me when you see what the government has done and that is that they took, quoting Dr. Birx: "We've taken a very liberal approach to mortality." (*Meaning*, *Dr. Birx's doesn't care how many people will die? May the reader interpret what she said.*)

If my husband were to die who has COPD, his lungs have fibrosis, his lungs would look exactly like somebody with COVID-19 theoretically, but he has no evidence of infection. So if you're not testing, and you don't have evidence of infection, and if you walked in there today, you know, they call it COVID-19. And we hear this from the doctors and nurses who are upset.

(Mikki Willis:) I've seen so many doctors online that have made their own web cam videos just perplexed by the protocol that the CDC had given them.

(**Doctor:**) Well, last Friday I received a seven-page document that sort of told me that if I had an 86 year old patient that had pneumonia but was never tested for COVID-19, but sometime after she came down with pneumonia, we learned that she had been exposed to her son who had no symptoms, but later on was identified with COVID-19, that it would be appropriate to diagnose on the death certificate COVID-19.

(**Doctor:**) When I'm writing up my death report I'm being pressured to add COVID. Why is that? Why are we being pressured to add COVID? To maybe increase the numbers and make it look a little bit worse than it is? I think so.

(**TV interviewer to a doctor:**) Why would they want to skew the number of deaths due to COVID-19?

(**Doctor:**) Well, fear is a great way to control people, and sometimes people this ability to think for themselves is paralyzed if they're frightened enough. And that's not what I want people to be. I want people to say we're gonna get through this. I'm gonna use my head. I'm gonna go to different sources. I'm gonna listen to different sources. And I'm gonna think for myself because that's what America is about.

(**Dr. Brix:**) If someone dies with COVID-19 we are counting that as a COVID-19 death.

(Dr. Mikovits:) You don't die with an infection. You die from an infection.

(Mikki Willis:) I've talked with doctors who have admitted that they are being incentivized to list patients that are sick or have died with COVID-19.

(Dr. Mikovits:) Yeah, \$13,000 for Medicare if you call it COVID-19.

(**TV announcer:**) Right now Medicare is determined that if you have a COVID-19 admission to the hospital, you'll get paid \$13,000. if that COVID-19 patient goes on a ventilator, you get thirty nine thousand dollars, three times as

much.

(**Dr. Mikovits:**) And you've killed them with the ventilator because you gave them the wrong treatment.

(A doctor on video:) All the things that just don't make sense, the patients I'm seeing in front of me, the lungs I'm trying to improve, have led me to believe that we are operating under a medical paradigm that is untrue. and I fear that this misguided treatment will lead to a tremendous amount of harm to a great number of people in a very short time.

(Mikki Willis:) My next question is about Italy. I want to know why Italy was hit so hard.

(**Dr. Mikovits:**) Italy has a very old population. They're very sick with inflammatory disorders they got at the beginning of 2019, an untested new form of influenza vaccine that had four different strains of influenza including the highly pathogenic H1N1. That vaccine was grown in a cell line, a dog cell line, dogs have lots of coronaviruses, and that's why they're not testing there. You could just say, "oh it was that!"

(**News announcer:**) As the country begins emerging from the worst of the corona virus epidemic one question remains. What happened to all the hydroxychloroquine?

(A doctor:) We know that hydroxychloroquine and zinc are working great for patients. And then Fauci comes out and says "there's no double-blind control placebo study" which, by the way, Dr. Fauci, is there going to be a double-blind control placebo study of your vaccine? Is there?

(News announcer:) In a survey polling nearly 2,300 doctors in some 30 countries hydroxychloroquine was ranked as the most effective medication to treat the virus.

(Dr. Mikovits:) The AMA was saying you know doctors will lose their license if they use hydroxychloroquine, the anti-malarial drug that's been on the list of essential medicine worldwide for 70 years! Dr. Fauci calls that anecdotal data! It's not storytelling if we have thousands of pages of data saying it's effective against these families of viruses! This is essential medicine, and they keep it from the people, not only now, but back in autism with our discovery, there was an old antiviral drug hundred-year-old drug called seromon on the WHO list of essential medicine. You literally gave kids with autism a voice, a life. What did Bayer and Monsanto do? They took it away from everybody! You couldn't get it to save your life right now. We tried, believe me, every way we could. So when you take away a medicine, and not just the WHO, the FDA, the CDC, Tony Fauci, close everything. Just end it all and we've got a healthy world again, and we got tons of money because we can take all that money they're making on their patents and we can give it to the victims of this plague of corruption.

(Mikki Willis:) Is it safe to say that anything that cannot be patented has been shut down intentionally because there's no way to profit from it? — All

these natural remedies that we have had forever.

(**Dr. Mikovits:**) Absolutely. That's fair to say. And that's exactly what's going on in COVID-19. **The game is to prevent the therapies until everyone is infected and push the vaccines knowing that the flu vaccines increase the odds by 36 percent of getting COVID-19!**

(Mikki Willis:) Where does that data come?

(**Dr. Mikovits:**) From a publication last year where the military who had been vaccinated with influenza were more susceptible to corona viruses. Corona viruses are in every animal. So if you've ever had a flu vaccine, you were injected with corona viruses. and then to put on a mask ...

(**Doctor:**) This doesn't make any sense. We wear masks in an acute setting to protect us. We're not wearing masks. Why is that? Because we understand microbiology, we understand immunology, and we want strong immune systems. Our immune system is used to touching. We share bacteria staphylococcus, staphylococcal bacteria, viruses. We develop an immune response daily to this stuff. When you take that away from me, my immune system drops. As I shelter in place, my immune system drops. You keep me there for months, it drops more. And now I'm at home hand-washing vigorously, washing the counters, worried about things that are indeed what I need to survive.

(A doctor next to the first doctor:) You know you're not immunodeficient, and you're not elderly, you should be able to go out without any gloves and without a mask. I think if you are those things you should either set shelter in place or wear a mask and gloves. I don't think everybody needs to wear masks and gloves because it reduces your bacterial flora. It doesn't allow you to interact with society and your bacterial flora and your viruses, your friends that protect you from other diseases end up going away, and now you're more likely to get opportunistic infections, infections that are hoping you don't have your good bugs fighting for you if that makes sense.

(Another doctor:) And then as we all come out of shelter-in-place with a lower immune system and start trading viruses, bacteria, what do you think is gonna happen? Disease is gonna spike!

(Another doctor:) I guarantee when we reopen there's going to be a huge huge amount of illness that's going to be rampant. The building blocks of your immune system is virus and bacteria, end of story.

(**Dr. Mikovits:**) Wearing the mask literally activates your own virus. You're getting sick from your own reactivated corona virus expressions, and if it happens to be SARS-CoV-2, then you've got a big problem.

(Mikki Willis:) You're not the first virologist who has told me that we're doing the exact opposite of what we should be doing to contain and to create immunity from this virus.

(**Dr. Mikovits:**) Why would you close the beach? You've got sequences in the soil, in the sand. You've got healing microbes in the ocean in the saltwater. That's insanity! (Thank God the governor of Guam re-opened the beaches!)

- (Mikki Willis:) These institutions that are polluting our environment and our bodies, there was a time when they actually had to fight their own battles, but they've done such a great job at manipulating the masses, that it's other people shutting down other citizens, and the big tech platforms follow suit, and they shut everything down. There is no dissenting voices allowed anymore in this free country, which is something I never thought I would live to see.
- (**Dr. Mikovits:**) Nor would I except what I've experienced since 2011. It's beyond comprehension how a society can be so fooled that the types of propaganda continue to where they're just driving us to hate each other. Hopefully, this is the wake-up call of all America to realize this makes no sense, and we win because it will take down the whole program with information like this. And for me it's the great news that the doctors are waking up and saying "wait a minute!"
- (**Doctor:**) You doctors that are watching this and I see a lot of you right here, why are you not getting loud? I'm here to defend you. I'm here to defend my freedoms. I'm here to defend my family's freedoms, my patients rights to choose what to do with their life. I'm just blown away! And I'm blown away why there are not more doctors like me talking about this all over the place. We should be banding together right now! You need to wake up because your liberties are getting taken away from you all because of fake news is out there. This is wrong! People should be going to jail for this stuff.
- (**Dr. Mikovits:**) So it's not the scientists who are in any way dishonest. They're listening to people who for more than 40 years have controlled who gets funded, what gets published, and I'm sorry to say many many people will simply take the money and the fame and that support, things that absolutely aren't true.
- (Mikki Willis:) What do you say to the medical professionals that are just beginning to get a glimpse of the depth to which they have been misled and steered away from their oath to do no harm?
- (**Dr. Mikovits:**) I say forgive yourselves. It's the hardest thing to realize for all of us and is that with all the best intentions we studied we learned what we thought was the truth we had no idea that the data that we were being told was true, was not true. We've been taught now in our schools a very different science, you don't get funded if you don't speak the party line you don't get published. That was probably the hardest thing for me to take, is understanding that scientific journals would twist the discovery that should have healed all.
- (**Lady doctor:**) Will the scientific community have the courage to answer the question of whether these diseases might have been of their own creation? Thank you. (Applause)
- (**Dr. Mikovits:**) So what we did pretty much ever since I got out of jail, we started an education company. We wake up doctors. And it's very difficult, but every doctor who realized they may have been part of the problem has now turned that around to march toward a better society and restore faith in the

promise of medicine. That's all we can do.

(Mikki Willis:) Well, Dr. Mikovits, thank you so much for your time it's been a real honor to sit here with you and particularly thank you for your courage.

(**Dr. Mikovits:**) Thank You Mikki, I appreciate it a lot.

(**Dr. Anthony Fauci:**) The idea that we are now a few days away from a new administration, given as you heard from the introduction that I have been around for a while and have had the opportunity of serving in five administrations, I thought I would bring that perspective to the topic today as the issue of pandemic preparedness. And if there's one message that I want to leave with you today is that there is no question that there will be a surprise outbreak. ... The thing that we're extraordinarily confident about is that we are going to see this in the next few years. Thank you. (Applause)
